Re: Public Record Request – Arrest Report of Eugene McQuade

Dear Sir/Madam:

I am in receipt of your Public Record Request of January 23, 2018 for any/all records related to the above-referenced arrest. Your request is governed by the Access to Public Records Act contained in R.I.G.L. Chapter 38-2. In response to a request for public records, an agency is required to make available for public disclosure those records that are responsive to a request, are in the possession of the agency and are not otherwise exempted from disclosure.

Enclosed please find a copy of the initial Arrest Report Number 18IK2-32-AR, with redactions. Rhode Island General Laws § 38-2-2(4)(D)(a) and (b) exempt records in law enforcement files that could reasonably be expected to interfere with investigations of criminal activity or with enforcement proceedings, along with records which would deprive a person of a right to a fair trial or an impartial adjudication. Additionally, Rhode Island General Law § 38-2-2(4)(D)(c) exempts personal information relating to an individual in any files and law enforcement records that could reasonably be expected to be an unwarranted invasion of personal privacy, or could disclose information furnished on a confidential basis. In accordance with these exemptions, the enclosed report has been redacted and all other portions of the report are presently omitted from release.

Furthermore, as the remaining records are exempt in their entirety under Rhode Island Law, no portions are segregable under Rhode Island General Law § 38-2-3(b).

In accordance with R.I. Gen. Laws § 38-2-8, you may appeal this decision to Col. Ann C. Assumpico, Superintendent, Rhode Island State Police, 311 Danielson Pike, North Scituate, Rhode Island 02857. Or you may file a complaint with the Department of the Attorney General, 150 South Main Street, Providence, Rhode Island, 02903, or the Rhode Island Superior Court of the county where the record(s) are maintained.


